Market and Credit Risks	
You are exposed to Concentration risk. <ul style="list-style-type: none"> Focusing on any company, industry, sector, country, region, type of stock, type of economy, etc. makes the Underlying Fund more sensitive to the factors that determine market value for the area of focus, which may result in higher volatility and a greater risk of loss. You are exposed to equities risk. <ul style="list-style-type: none"> Equities can lose value rapidly, and typically involve higher market risks than bonds or money market instruments. You are exposed to market risk. <ul style="list-style-type: none"> Prices and yields of securities can change frequently with significant volatility based on a wide variety of factors, such as political and economic news, government policy and climate patterns. 	
Liquidity Risks	

The ILP sub-fund is not listed on the Singapore Exchange and you can redeem only on Business Days through Singapore Life Ltd. In respect of Singapore investors, there is no secondary market for the ILP sub-fund.

Product-Specific Risks

You are exposed to counterparty and collateral risk.

- A counterparty could be unwilling or unable to meet its obligations to the Underlying Fund. The value of collateral might not cover the full value of a transaction, or any fees or returns owed to the Underlying Fund.

You are exposed to currency risk.

- Any changes in currency exchange rates could significantly reduce investment gains or income, or increase investment losses.

You are exposed to derivatives risk.

- The value of derivatives can be volatile. Small movements in an underlying asset's value can create large changes in the derivative's value and expose the Underlying Fund to losses that could be greater than the cost of the derivative itself.

You are exposed to hedging risk.

- Hedging may not work as intended and involves costs, which reduce investment performance.

You are exposed to investment fund risk.

- Investing in an Underlying Fund involves certain risks an investor would not face if investing in markets directly, such as large outflows, valuation error and investment limitations.

You are exposed to operational risk.

- The Underlying Fund could suffer losses due to errors, service disruptions or other failures, fraud, corruption, cyber crime, instability, terrorism or other irregular events.

VALUATIONS AND EXITING FROM THIS INVESTMENT

HOW OFTEN ARE VALUATIONS AVAILABLE?

All ILP sub-funds will be priced based on the frequency of the fund manager's pricing. The fund prices are updated daily and are available at Singapore Life Ltd.'s website at www.singlife.com.

HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?

- You can exit the ILP sub-fund by submitting a request for withdrawal or fund switching (i.e. switches) to Singapore Life Ltd.
- If your Policy is newly inceptioned, you may cancel the Policy by giving us written notice of cancellation provided that such notice of cancellation is received by Singapore Life Ltd. at its Registered Office within the free-look period, which is fourteen (14) days from the date on which you receive the Policy.
- Upon cancellation of the Policy, Singapore Life Ltd. will refund the premiums you paid (without interest) after deducting the expenses incurred in issuing the Policy. The refund will be made after we receive the original Policy for cancellation.
- If there has been a decline in the market value, we will deduct the amount necessary to reflect the change in market value. If there has been an increase in the market value following the date Singapore Life Ltd. accepts your request to cancel the Policy, we will not pay you for such increase or any gain.
- For subsequent withdrawal/surrender or fund switching, transaction requests will need to be received and accepted by Singapore Life Ltd.:
 - before 12 noon (Singapore time) on a Business Day will be processed according to the Unit Prices of the relevant Funds and the exchange rates (if applicable) prevailing on the next appropriate Fund Valuation Date following the day Singapore Life Ltd. has accepted the request.
 - after 12 noon (Singapore time) on a Business Day or on a non-business day will be considered as if received before 12 noon (Singapore time) on the following business day.
- The ILP sub-fund will have a single "dealing" price used for all switches and withdrawals/surrenders. There is no bid/offer spread.
- All ILP sub-funds will be priced based on the frequency of the fund manager's pricing policy. As Units are cancelled using a forward price, the unit price for all switching and withdrawal of units will not be available at the time of receiving your application.
- This cut-off time stated is correct as at the time of print. Singapore Life Ltd. reserves the right to change the cut-off time by giving you thirty (30) days' prior notice or any such shorter period of notice as Singapore Life Ltd. may agree with the relevant authorities.
- The Withdrawal Amount you will receive as part of a subsequent withdrawal is illustrated as follows:
For a partial withdrawal request of 1000 units of an investment-linked fund.
 - Assuming the unit price of the fund is S\$1.50:

APPENDIX: GLOSSARY OF TERMS

Business Day:	A day on which the banks in Singapore and Luxembourg are normally open for business.
Fidelity Sustainability Ratings:	A proprietary ESG rating system developed by Fidelity's research analysts to assess individual issuers.
Manager:	Referred to as the Management Company in the Prospectus.
NAV:	As the case may be, the value of the assets less liabilities of the Fund, of the Underlying Fund, of a class of Shares or of a Share in the Underlying Fund determined in accordance with the "Net Asset Value and Swing Pricing" section of the Prospectus.
Prospectus:	Singapore Prospectus of Fidelity Funds.
Underlying Fund:	Fidelity Funds - Sustainable Japan Equity A SGD
Valuation Date:	Each week day (any day Monday to Friday inclusive) excluding 25 December and 1 January as well as any other day which the Directors have determined, in the best interests of the Shareholders, as non-Valuation Dates. Non-Valuation Dates may for example be any day observed as a holiday on a stock exchange which is the principal market for a significant portion of the investments attributable to the Underlying Fund, or any day which is a holiday elsewhere so as to impede the calculation of fair market value of the investments attributable to the Underlying Fund, which may also include any day immediately preceding such relevant market closure where the dealing cut-off time of the Underlying Fund occurs at a time when the relevant underlying main market is already closed to trading and the following days are a period of consecutive market closure days. The list of expected non-Valuation Dates is available on https://fidelityinternational.com/non-valuation-days/ and is updated in advance on a semi-annual basis. However, the list may be further updated from time to time in advance as is reasonably practicable in exceptional circumstances where the Directors believe that it is in the best interests of the Shareholders.
